

**CITY OF FERNAN LAKE
ORDINANCE 184**

AN ORDINANCE OF THE CITY OF FERNAN LAKE, IDAHO ENTITLED THE ANNUAL APPROPRIATION ORDINANCE FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2018, AND ENDING ON SEPTEMBER 30, 2019, APPROPRIATING THE SUM OF \$123,754.00 TO DEFRAY THE EXPENSES AND LIABILITIES OF THE CITY OF FERNAN LAKE FOR SAID FISCAL YEAR, AUTHORIZING A LEVY OF A SUFFICIENT TAX UPON THE TAXABLE PROPERTY AND SPECIFYING THE OBJECTS AND PURPOSES FOR WHICH SAID APPROPRIATION IS MADE.

BE IT ORDAINED by the Mayor and Council of the City of Fernan Lake, Kootenai County, Idaho:

Section 1: That the sum of \$123,754.00, be and the same is appropriated to defray the necessary expenses and liabilities of the City of Fernan Lake, Kootenai County, Idaho for the fiscal year beginning October 1, 2018.

Section 2: The objects and purposes for which such appropriation is made, and the amount of each object and purpose is as follows:



Section 3: That a general tax levy on all taxable property within the City of Fernan Lake be levied in an amount allowed by law for the general purposes for said City, for the fiscal year beginning October 1, 2018.

Section 4: All ordinances and parts of ordinances in conflict with this ordinance are hereby repealed.

Section 5: This ordinance shall take effect and be in full force upon its passage, approval and publication in one issue of the Coeur d'Alene Press, a newspaper of general circulation in the City of Fernan Lake, and the official newspaper of said City.
