CITY ORDINANCE FOR RECREATIONAL PARKING

Boats, RV’s and recreational equipment may be parked in your driveway May 1st—October 1st. Please, no tarps for covering. After October 1st, boats, RV’s and recreational equipment must be put into storage. We want everyone to enjoy your Idaho but protect the view of our neighbors and integrity of Fernan.

If the owners, tenants or occupants allow said nuisance to exist or fail to abate the nuisance, they, and each of them, shall be guilty of an infraction, punishable by a fine not to exceed ONE HUNDRED DOLLARS (\$100.00). Each day that a violation of this chapter exists may be charged as a separate offense. Three (3) or more infractions or a failure to pay the infraction penalty shall constitute a misdemeanor.

Jim and Sue Myers have lived in their home on Teresa Drive since April of 1991. Jim shared that they have always enjoyed their neighbors in Fernan since day one. They have also enjoyed gardening here and always get a decent corn, tomato and golden raspberry crop. He said the location is great and seems to

have its own "mini" climate that helps things grow. Sue said it was a great place to raise their children. There were a lot of families in the Village with children the same age. The kids easily found friends and it was a safe and fun place for them to grow up, much like her own childhood.

Sue was fortunate enough to be born in Coeur d'Alene and grew up in the Fort Grounds. As she said she moved from one end of Sherman to the other. Growing up in the Fort Grounds was fondly remembered by Sue as being an idyllic place. She enjoyed both the location and the freedom she had to join with friends and explore the town and the lake. Her walk to elementary school was about two blocks as she attended the old Sherman School located on the college grounds. Her seventh and

Jim didn't have quite the same experience of growing up in one town as Sue did. His father was an Air Force pilot and so they moved a lot. He was born in Sacramento, California while his dad was stationed at a nearby base. They moved around a lot until his dad retired from the Air Force and they built a home here. Sadly they lost their daughter Amie three years ago and as Jim remarked, "we still miss her everyday". Their son Chris went into the Air Force out of high school and stayed in for six years. After that he spent three years in Saudi Arabia and now lives in Seattle. Jaimee moved back here last year after living in Texas for six years. She is married to Grant Cox and opened an exercise studio on 4th street called Pure Barre. Her studio also sells work out attire featuring the popular Lululemon line.

Jim is a Minerals Geologist and during the earlier years of his career many of his contracts were in Central and South America requiring him to be gone for four to six weeks at a time. Sue was often cast in the role of single mom just as Jim's mother was as an Air Force wife. His career also gave them the opportunity for all the family to live in Buenos Aires, Argentina for a year. This gave the children a great experience of another culture. Jim has now worked for Hecla for ten years so his travel is mostly limited to the Silver Valley and some to Mexico. He lamented the time required now in the office as he loves being out in the field.

Sue has been a realtor for twenty years and says she is now semi retired which leaves more time for all the other things she likes to do including her gardening and now barre classes. She has also been active in civic events for years. Being friends with Mary Ann Tierney led to her becoming involved in events and activities in the Village and then serving on the Fernan City Council for fourteen years. During this time she and Mary Ann became even closer friends and remained so until Mary Ann's recent death.

Sue and Jim are a very active couple who love their chosen professions, but actually as Jim said they work to ski. It is their favorite pastime and obviously was how they got together. 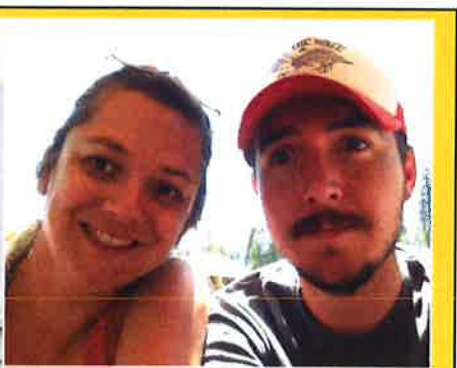
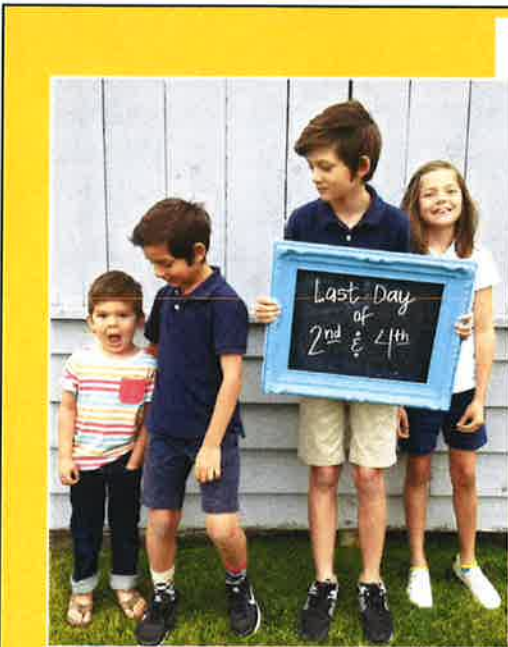
